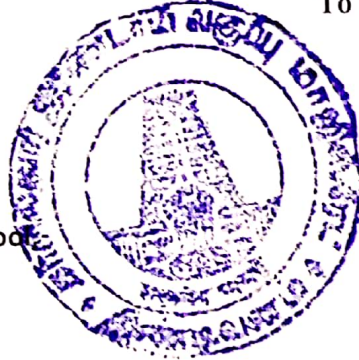
**ORDER:**

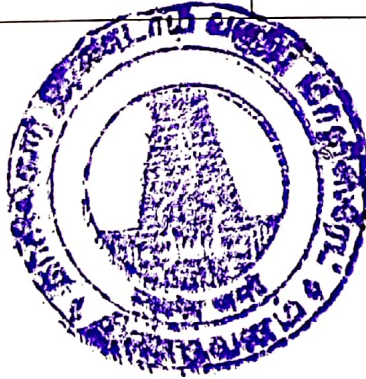
